## Inaugural Workshop: Building Cross-Border Sandboxes

---

The Datasphere Initiative's [Africa Forum on Sandboxes for Data](#) convenes leaders in government, industry, academia, civil society, and the technical community, to harness local perspectives and create trusted data-sharing solutions to address cross-border challenges in health, finance, sustainability, and AI.

Sandboxes are collaborative environments that test innovative technologies and data practices against regulatory frameworks, or experiment with new uses, capabilities, and means of governing data. While the use of sandboxes has been spreading in Africa, capacity building, sharing of good practices, and active testing are still needed in order to meet its full potential to address data issues across the continent. Cross-border sandboxes help us resolve certain data challenges that cannot be sufficiently addressed within national borders. Among other things, they make the vision of an interconnected continent a reality, and promote the AfCTA's ambition of a single digital market.

In this workshop, participants will receive a brief primer on digital integration on the continent and the role cross-border sandboxes can play in advancing it. They will hear perspectives from local partners, and evaluate examples of certain data governance issues that transcend borders. Then, participants will organize into breakout groups for a simulation exercise, in which each group will employ a six-step process, outlined in the [Sandboxes for Data](#) report, to build a cross-border sandbox aimed at addressing a pre-assigned data governance issue. At the end of the workshop, each group will present their findings and offer their reflections.
